The Annihilyzer® System is a revolutionary solution for product generation, containerization, and delivery with total inventory and activity tracking, reporting, and management of Hydrolyte® "Green Cleaning" and infection control systems for cleaning, sanitizing and disinfecting in hospitals, nursing homes, health care facilities, resorts and hotels, schools, correctional and other facilities. The Annihilyzer® is Green Seal™ Certified and produces two Green Seal™ Certified products (GS-37 and GS-53), which demonstrates highly effective solutions in both cleaning performance and germ control.

Paradigm provides integrated product and technology solutions for total facility cleaning and sanitizing. The acquisition of the Annihilyzer® technology will allow Paradigm to gain a distinct first-mover advantage in the onsite product generation market by providing its proprietary protocols and product and process tracking system to users in all markets.

Marty Paris, as Sr. Vice President of Paradigm's Annihilyzer® Division, will apply his proven abilities in innovation, business development and marketing to growing the divisions operations, revenue and earnings.
