Bingham Canyon to Acquire Annihilyzer Inc.

Bingham Canyon, through its wholly-owned subsidiary **Paradigm Convergence Technologies**, has agreed to acquire 100 percent of the shares of Annihilyzer Inc. in exchange for Bingham shares and a cash consideration. The cash consideration allows Annihilyzer shareholders to recapture the development costs of the technology portfolio being acquired in the Annihilyzer® System Solution. A definitive agreement is to be executed on or before December 1st.

The Annihilyzer® is a revolutionary, patent-pending system for the on-site product generation, containerization, delivery and utilization including total inventory and activity tracking, reporting, and management of Hydrolyte® and Catholyte applications in larger facilities such as hospitals, nursing homes, health care facilities, resorts and hotels, schools, correctional facilities and others.

Paradigm has supplied the product generation systems used in the Annihilyzer® while the other system components were designed and executed by Annihilare Medical Systems, Annihilyzer Inc.'s parent company. The acquisition of this complete package of technological innovations provides Paradigm with a breakout, one-of-a-kind capability in the industry, providing a vast array of cleaning, disinfecting and sanitizing solutions for facility managers.

Along with the ability to make fresh Anolyte and Catholyte on site, the Annihilyzer® System uses Radio-Frequency Identification (RFID) technology to allow cleaning personnel to effectively track the life cycle of the product. It also tracks which rooms have been treated, the time they were completed, who actually did the job and whether or not it was done properly – and it can even flag a room with a known pathogen, for extra precaution.

The Annihilyzer® uses RFID technology to manage the product expiration and usage information. When a container is filled an expiration date is assigned to the container. The system keeps track of who filled the container and when, ensuring fresh product usage every time. In the case of an expired container being presented, it alerts the user to empty and refill the container - ensuring the quality and strength of the product.

Each room is outfitted with an RFID checkpoint decal. Using the Annihilyzer's mobile app and an NFC-enabled device such as a smartphone, tablet or wearable, users will "tap in" to each room before beginning a daily clean, terminal clean, etc. The app prompts the room cleaner with a list of tasks to be done. After following proper cleaning and infection control procedures provided by Paradigm, the user will select the tasks that were performed in the room, generating a room report including time and duration of the clean when the user "taps out" at the checkpoint. This powerful automated reporting tool allows managers to access valuable data in the daily records of cleaning routines for operations and cost analysis and planning..

Each RFID checkpoint decal has a unique QR code that can be scanned by any smartphone with a QR Reader app. This allows facility administrators, cleaning personnel, and even patients' family members to see the room reports - showing them when the room was cleaned, who cleaned it and what was done.

Paradigm and Annihilare Medical Systems introduced the Annihilyzer® solution to the facilities management and sanitation industries at the IEHA and ISSA/InterClean North America Trade Shows which were both held at McCormick Place in Chicago, Illinois during the week October 24th to 28th.
